# ADDRESS OF WELCOME OF THE EXECUTIVE DIRECTOR/CEO OF THE NATIONAL FILM AND VIDEO CENSORS BOARD (NFVCB) AT THE 5TH PEACE ANYIAM OSIGWE (PAO) NIGERIA DIGITAL CONTENT REGULATION CONFERENCE.

#### Protocols.

It is my great pleasure to welcome you all to the 5th edition of the Peace Anyiam-Osigwe Nigeria Digital Content Regulatory Conference. It is both an honour and a privilege to stand before you today as we gather to explore a theme that sits at the heart of our industry's future: "From Volume to Value: The Future of Nollywood in the Digital Age."

As we reflect on how far we have come as an industry, it is important to acknowledge the vision that gave birth to this conference. Since its establishment in 2021, the Peace Anyiam-Osigwe NDCRC has served as a unifying platform for industry professionals, thought leaders, innovators, and operators. Named in honour of the late iconic writer, filmmaker, and producer Peace Anyiam-Osigwe in 2023, this conference was designed to foster collaboration, knowledge exchange, and responsible innovation, especially in a fast-evolving digital landscape.

Distinguished guest, ladies and gentlemen, it has now been a year and eight months since I assumed office as the Executive Director and CEO of the NFVCB. In that time, we have worked with purpose and determination to strengthen the regulatory foundations of our industry while enabling creativity, innovation, and global competitiveness. Our journey has been both exciting and instructive, marked by significant milestones. For instance, we have:

- enhanced regulatory efficiency, including the introduction of a quick comeback time for film classification, enabling filmmakers to obtain certificates swiftly and distribute their works without unnecessary delays.
- strengthened compliance and enforcement, ensuring films meet statutory standards and that audiences—especially young people—are protected from harmful or unclassified content.
- advanced a major institutional priority: the shift from censorship to classification. This philosophy is at the
  heart of our bill currently receiving attention at the National Assembly, which seeks to officially re-designate
  the NFVCB as a classification organization—simply, "The Classifier." This transition reflects our belief in
  empowering audiences, supporting creative freedom, and providing clearer guidance rather than restricting
  expression.
- empowered filmmakers, distributors, and content creators through capacity-building programmes, workshops, and stakeholder engagement to meet local and international expectations.
- fostered collaboration and digital innovation, leveraging technology to improve licensing, distribution processes, and the protection of intellectual property.
- expanded our media literacy initiatives, equipping audiences to critically evaluate the content they consume while strengthening international partnerships for exchanges and intellectual property protection and lastly we

have

 made the 2024 regulation on the control of the promotion and glamourization of tobacco, tobacco product, nicotine product, money ritual and ritual killing display in films, musical videos and skits.

These achievements are the result of the hard work of the NFVCB management and staff, the cooperation of industry stakeholders, and the resilience of the Nigerian creative community. I invite everyone to kindly join me in giving the Board's team a well-deserved round of applause.

Despite this progress, our industry continues to face challenges that demand urgent attention. One of the most pressing is the unauthorized uploading, streaming, and distribution of films on online platforms, especially YouTube and other digital channels, without recourse to the NFVCB for classification or licensing. This practice is a clear violation of the law establishing the NFVCB. Sections 2b&e, and Sections 25,28 and 33(1) of the NFVCB act makes it an offence to upload, distribute, stream, or exhibit films or video works without recourse to the NFVCB for classification and or licensing. Regrettably, many practitioners—and even some telecommunications companies—continue to distribute unclassified content. This must stop. We appeal to all filmmakers, distributors, digital platforms, and Telcos to comply fully with the law.

As we look to the future, our commitment remains firm: to build a Nollywood that is responsible, forward-looking, globally competitive, and anchored in a strong regulatory culture. We are deepening our digital licensing systems, enhancing enforcement structures, and expanding capacity-building initiatives to make compliance easier, faster, and more transparent.

Today's conference gives us the opportunity not just to reflect on our strides and challenges, but to collectively shape a vision for the future—a future where Nollywood no longer measures success in sheer numbers, but in value: value for audiences, value for investors, value for creators, and value for Nigeria.

Before we proceed, I wish to express my profound appreciation to:

- the stakeholders of the motion picture industry who have received me with so much warmth and supported me and my team
- the Honourable Minister of Information and Culture, Barrister Hannatu Musa Musawa for her unwavering guidance and support;
- the Chairman of the House Committee on Arts, Culture and Creative Economy Hon. Gabriel Saleh Zock and the Managing Director of the Bank of Industry Dr. Olasupo Olusi, for graciously accepting to be special guest and to chair this event;
- And to Olori Temitope Enitan-Ogunwusi, we say thank you for accepting—at very short notice—to be our Royal Mother of the Day.

As part of today's activities, we will be presenting five industry awards, along with three special honours: Box Office Champion, Audience Choice Award, and Emerging Distributor Award and three special recognition awards for service to the industry especially in the area of distribution, exhibition and internalization of the brand Nollywood. # NATIONAL FILM AND VIDEO CENSORS BOARD (NFVCB)

The National Film and Video Censors Board (NFVCB) is the regulatory body set up by Act No.85 of 1993 to regulate films and video industry in Nigeria. As a parastatal of the Federal Ministry of Art, Culture, Tourism and Creative Economy, the NFVCB is empowered by law to classify all films and video works including short drama contents and musical videos whether imported or produced locally. It is also the duty of the NFVCB to register all films and video outlets across the country and to keep a register of such registered outlets among other functions across the country and to keep a register of such registered outlets among other functions.

#### Mission Statement

To contribute to the positive transformation of the Nigerian society through the censorship of films and video works whilst balancing the need to preserve freedom of expression within the law, and limit social harm caused by films.

#### Our Vision

To be recognized as a world-class film and video regulatory agency that institutes best practice in the discharge of its duties.

#### The functions of the Board are:

- To License a Person to exhibit films and video works
- To license a premises for the purposes of exhibiting films and video works
- To classify films and video works
- To regulate and prescribe safety precautions to be observed in licensed premises
- To regulate and control cinematographic exhibitions
- To regulate the import of foreign movies and export of Nigerian movies
- To perform such other functions as are necessary or expedient for the full discharge of all or any of the functions conferred on it by law.

# THE PEACE ANYIAM-OSIGWE NIGERIA DIGITAL CONTENT REGULATION CONFERENCE



The Nigeria Digital Content Regulation Conference was conceived in 2020 during the tenure of Alhaji Adedayo Thomas as a platform for robust dialogue and to bring key industry players, policy makers and relevant stakeholders together to chart a common front towards repositioning Nigeria's highly esteemed and growing film industry. The conference was actually birthed in December 2021 and conversations in each edition have largely focused on regulations in the film industry, with specific attention to the impact of filmmakers, content creators and streaming services on Over-The-Top, social media and other digital and online platforms, intellectual property protection and the need to bring balance and equity to the ecosystem, especially with the ever-evolving innovative disruption of the digital era.

The past three editions have attracted active participation by OTT streaming global players, plus Pay TV, Telcos, local streamers and other relevant stakeholders in the industry, including film producers, exhibitors, distributors and actors.

The first two editions held as NDCRC but in 2023, that edition of the conference was dedicated to the loving memories of Peace Maria Ogechi Anyiam-Osigwe, MFR, founder of the prestigious African Movie Academy Awards (AMAA), who passed away on January 7, 2023, at the age of 55years.

She was the first female President of the Association of Movie Producers (AMP) and the pioneer President of the Federation of Registered Nollywood Guilds and Associations of Nigeria (FRENGAN), the two impactful roles she held until her demise. The Peace Osigwe who was popular as PMO was pivotal to the initiation of this conference and was a bridge-builder between the NFVCB, as the industry regulator, and the film industry practitioners and stakeholders. To preserve the memories of this great icon, the NFVCB named the conference the "Peace-Anyiam Osigwe Digital Content Regulation Conference".

Bolanle is the visionary founder of Terra Academy for the Arts (TAFTA), in partnership with the Mastercard Foundation, where over 53,000 aspiring creatives have been trained. In 2024, Bolanle founded the Lagos International Theatre Festival, creating an annual platform for local and international theatre companies to converge in Nigeria. The inaugural festival was a resounding success, featuring local theatre companies and international companies from the United States, South Africa, and Zimbabwe.

She is the Founder of Terra Kulture, a multi award winning centre and a foremost tourist destination in Nigeria with over 300 art exhibitions, a famous restaurant and the most successful theatre in Nigeria with over 250 different plays having been exhibited there in the past 21 years.

Her remarkable contributions to the arts have earned her numerous accolades, including a prestigious fellowship at MIT and repeated features in Forbes as one of Africa's Top 100 Leading Women.

Bolanle Austen-Peters continues to be a transformative force in Africa's creative industries, inspiring new generations through her visionary leadership, innovation, and unwavering dedication to excellence.

REQUIREMENTS FOR ONLINE CLASSIFICATION
(EXCLUDING LOCAL AND FOREIGN MOVIES INTENDED FOR EXHIBITION)



- To CLASSIFY your film via the online platform, the following is required:
- 1) That the producer of the film must be a member of a registered association with NFVCB
- 2) Make PAYMENT on the FG Remita platform: 45,000 for 31 to 60 minutes: 55,000 for 61 to 90 minutes: 65,000 for 91 to 120 minutes: 75,000 for 121 to 150 minutes. (English movies)

For Nigerian films in local language: Make a Remita payment of 35,000 for 31 to 60 minutes: 45,000 for 61 to 90 minutes: 50,000 for 91 to 120 minutes: 55,000 for 121 to 150 minutes.

- 3) Upload the movie via Google drive or We transfer to verification@nfvcb.gov.ng and copy nfvcbonline@gmail.com
- 4) Write an application for censorship on company letter head, stating the following:
  - a) producers name and association
  - b) directors name and association
  - c) distributor

d) whose name the certificate will be written in(either the producer, executive producer or production company) and send to the above stated emails.




















































































# ISSUED FROM THE 4TH EDITION OF THE PEACE ANYIM OSIGWE NIGERIAN DIGITAL CONTENT REGULATION CONFERENCE.

The conference, organized by the National Film and Video Censors Board (NFVCB), was convened to assess current developments and challenges within the film and video industry, especially in an era marked by digital innovation and technological advancement.

The primary focus was to strike a balance between fostering creativity and upholding responsibility. The following points summarize the key highlights and issues that require attention and further discussion:

- 1. The conference acknowledged the commendable work of the National Film and Video Censors Board (NFVCB), particularly under its current management. Participants urged all stakeholders to continue supporting the board to enhance its effectiveness.
- 2. A significant proposal discussed was the rebranding of the board's public image to reflect a more approachable and supportive role. Changing the name from "censor" to "classification" was widely viewed as a positive step. Stakeholders called on relevant authorities, particularly the National Assembly, to provide the necessary legal framework through legislative action.
- 3. Participants recognized Artificial Intelligence (AI) and other emerging developments as integral advancements that is here to stay. Industry practitioners were encouraged to familiarize themselves with AI technologies and its associates to harness their potential benefits and integrate them effectively into their works.
- 4. It was agreed that authentic storytelling—remaining true to the Nigerian narrative should be prioritized as the primary pathway to achieving global recognition. Filmmakers were urged to ensure genuine and accurate portrayals of characters, cultures, and lifestyles.
- 5. The conference emphasized that industry practitioners must remain conscious of their social responsibility. They were reminded to maintain a commitment to truth, ethical standards, and fidelity to accuracy in their productions.
- 6. The conference stressed the necessity for National Film and Video Censors Board to establish cohesive structures to address the current fragmentation among stakeholder groups. Implementing these recognizable structures will enhance relationships between the agency and stakeholders while also regulating the content shared with the public. This approach aims to streamline communication and ensure a more organized and effective engagement with all parties involved.

- 7. The conference highlighted that collaboration among film industry practitioners, especially in sourcing funding, is crucial for elevating the industry to its full potential. Achieving this requires trust and strong partnerships between filmmakers, marketers, financiers, and distributors. These collaborative efforts can lead to more robust funding mechanisms and the creation of high-quality productions that resonate on both local and global scales.
- 8. Conference identified the sub-Saharan African as a region that investors are hugely interested investing funds for content creation. For Nollywood to participate in the financial windfall, The National Film and Video Censors Board is charged with the responsibility of identifying and empaneling a committee to work out modality for the industry to benefit from the projection.
- 9. The conference charged Nollywood to be intentional with storytelling to preserve and document Nigerian rich heritage especially as the world increasingly become global in all spheres. Story tellers must have a sound understanding of the culture they want reflect in their stories. Producing in the indigenous language is key to preservation drive.
- 10. The conference advocates for the review of educational curriculum to inculcate culture from elementary to tertiary levels. Film is not just a cultural icon but its preserver as well.
- 11. The conference recognized that beyond regulation, standardization and creating necessary ambience to achieve industry standards, there is need to devote efforts to infrastructural development as this will aid optimization of industry goals.
- 12. The conference made a urgent call on the industry stakeholders to rise to the trending developments in the film world. It thrives on quality, standards, data, structures and understanding of dynamics that drive digitalization.

The discussions and insights from the conference underscored the importance of ongoing collaboration between the film industry, government entities, and private sector partners to navigate the evolving landscape of digital content creation and regulation.

# WHAT THE LAW SAYS ABOUT CLASSIFICATION, DISTRIBUTION & EXHIBITION OF FILM AND VIDEO CONTENT

- The National Film and Video Censors Board Act 2004 (the NFVCB Act) provides among others:
- Every film or video content to be distributed or exhibited in Nigeria must be Classified by the Board (Section 2(b)and 33(1) Of the NFVCB Act):
- It is a criminal offence to distribute or exhibit a film (including foriegn films) and video content that has not been registered or classified by the Board (section 28 Of the NFVCB Act)
  - Distributing or exhibiting films or video content without first obtaining a license from the Board is a criminal offence punishable under the law (section 25 Of the NFVCB Act):
    - Section 2 (e) of the NFVCB Act states: It shall be the duty of the Board to perform such other functions as are necessary or expedient for the full discharge of all or any of the functions conferred on it by this Act.
